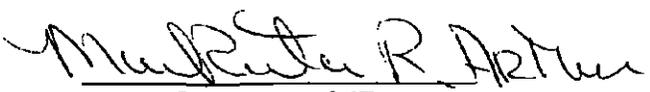

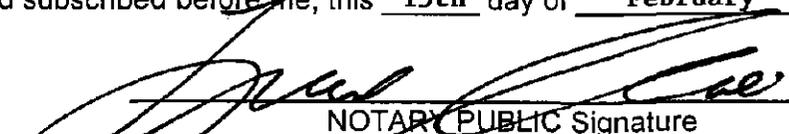
AFFIDAVIT
