

Naquin, Jr., Parish of Plaquemines, Justice of the Peace Ward Six, to accept said appointment,


IT IS ORDERED THAT:

Justice of the Peace Davey L. Naquin, Jr., Parish of Plaquemines, Justice of the Peace Ward Six, be and he is hereby appointed as Justice of the Peace pro tempore for the Parish of Plaquemines, Justice of the Peace Ward Four, effective July 1, 2020 through June 30, 2021, or until the vacancy is filled, whichever occurs sooner, or until further order of this Court, at which time this appointment shall terminate.

This Order shall not deprive Justice of the Peace Davey L. Naquin, Jr. of his office as justice of the peace for the Parish of Plaquemines, Justice of the Peace Ward Six, or of any other court to which he may have been assigned by previous order of this Court.
